"Bidding will be conducted through National Competitive Bidding (NCB). Since the Estimated Value of Work to be performed under this procurement (excluding VAT and other taxes) is below Rs. 50 Mn, regional preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016 (iii)".

3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered with the Construction Industry Development Authority (CIDA) in the field of building construction for grade mentioned in the table below.
